GREETINGS:

You are hereby notified that a special town meeting in the Town of Eagle Lake will be held at Powell Gymnasium located at 35 Carter Street, in Eagle Lake, on Wednesday, October 1, 2025, at 6:00 P.M. for the purpose of acting on the following articles, to wit:

**Article 1:** To choose a Moderator to preside at said meeting.

Motion made by Arthur Carroll to nominate Cyr Martin as moderator for the meeting, seconded by Adele Carroll.

Vote: Unanimously in favor

**Article 2:** To see if the Town will vote to authorize the Board of Selectmen to utilize an additional \$55,000 from the Undesignated Fund Balance for the purpose of reducing FY 2025/2026 property tax commitment and maintaining the mil rate at 15.78.

**SELECTMEN RECOMMEND PASSAGE**

**Notes:**

*If passed, the Total Amount from Undesignated Funds used to reduce FY25-26 property taxes is \$155,000.00*

*As of the Annual Municipal Audit for the year ending June 30, 2024, the total amount in Undesignated Funds is \$ 932,801.00*

**Article 3:** To see if the Town will vote to change the date interest accumulates on taxes unpaid as of a certain date; if so, what date.

**SELECTMEN RECOMMEND: Change the date from October 1, 2025, to November 15, 2025**

Motion made by Thomas Ripp to approve the article as read, seconded by Gilles Daigle.

**Article 4:** To see if the town will vote to authorize the Board of Selectmen to expend \$30,000 from the Town of Eagle Lake's Undesignated Fund account to purchase a 1993 International HME 4900 pumper fire engine from the Levant Fire Department.

***As of the Annual Municipal Audit for the year ending June 30, 2024, the total amount in Undesignated Funds is \$ 932,801.00***
