You are hereby notified that a special town meeting in the Town of Eagle Lake will be held at Powell Gymnasium located at 35 Carter Street, in Eagle Lake, on **Wednesday, September 18, 2024, at 6:00 P.M.** for the purpose of acting on the following articles, to wit:

Article 1: To choose a Moderator to preside at said meeting.

Article 2: To see if the Town will vote to authorize the Board of Selectmen to utilize an additional \$20,000 from the Undesignated Fund Balance for the purpose of reducing FY 2024/2025 property tax commitment and maintaining the mil rate at 15.78.

SELECTMEN RECOMMEND PASSAGE

Notes:

If passed, the Total Amount from Undesignated Funds used to reduce FY24-25 property taxes is \$100,000.00

As of the Annual Municipal Audit for the year ending June 30, 2023, the total amount in Undesignated Funds is \$ 879,715.00


Article 3: To see if the Town will vote to change the date interest accumulates on taxes unpaid as of a certain date; if so, what date.

Note: This date is for this year only.




