Article 2: To see if the town will vote to authorize the Board of Selectmen to expend \$25,000 from the Fire Department's Capital Reserve account to purchase a 2001 Freightliner rescue truck from the Lavant Fire Department to replace the 2002 Ford F150 pickup truck that was taken out of service for failing to pass a state of Maine motor vehicle inspection.

(Note: The Fire Department's Capital Reserve account balance is currently \$65,987.24)

Article 3: To see if the town will vote to authorize the Board of Selectmen to dispose of the 2002 Ford F150 on terms and conditions that they believe are in the best interest of the Town and dedicate the proceeds to the Fire Department's Capital Reserve account.
